

### Message From the President Martin County Bar President - Barbara Kibbey Wagner, Esq. **HONORING BLACK HISTORY MONTH**

This February, in honor of Black History Month, I wanted to take a moment to reflect and celebrate the achievements of members of the African American community.

On August 28, 1963, at the Lincoln Memorial in Washington, D.C., Martin Luther King delivered his infamous "I Have a Dream" speech. It was a speech we have all heard and know, not only because Dr. King spoke with such authority and conviction, but because the message was one that we all want: equality, unity, peace, love and freedom.

I recently moved my Stuart office to the historic Feroe building in Downtown Stuart. The building is more than 100 years old and at one point was a drugstore and/or soda shop. It has a few peculiar architectural niches



and structural "quirks" that interested me.

As a moving present, my mother gave me Luckhardt's Alice book. Images of America Stuart, which features our building on the cover. I couldn't help but wonder what life was like in Stuart through Civil the Rights movement, and Barbara Kibbey Wagner what businesses, like my office, were once like. I began to investigate.

Unfortunately, I never found answers regarding the interior of the building, but while perusing the pages, I stumbled upon a photo of African American pineapple laborers. According to the book, in 1900, only approximately 15 people in Stuart were African American, most of Bahamian descent.

Our little town has certainly come a long Today, Martin County has grown way. exponentially - enriched with diversity from all backgrounds. The list of individuals who have helped progress for all of us over this last century are far too numerous to name here.

Currently, though, our Bar Association is lucky enough to have two such trailblazing members that hold leadership positions in Gloretta Hall, Esq. as the first African American President of Martin County Women Lawyer's Association, and Eula Clarke as Mayor for the City of Stuart. This, of course, does not begin to mention the other countless members of our Bar that have paved the way and trailblazed paths toward equality and civil rights. Our community is certainly not perfect, but I prefer to be an optimist and believe that we are all working together to make it better for the next day ahead. Dr. King pleaded to those in D.C. decades ago, but his words still apply today:

"With this faith, we will be able to transform the jangling discords of our nation into a beautiful symphony of brotherhood. With this faith, we will be able to work together, to pray together, to struggle together, to go to jail together, to stand up for freedom together, knowing that one day we will be free."

I want to say thank you to all our African American lawyers, leaders, and members of the community for all that you have done and continue to do for the causes we hold so dear. Let us all continue to dream and work for a better tomorrow.

#### THE SILVER LININGS OF COVID-19 FOR WOMEN IN THE WORKFORCE

While we all rejoice in welcoming 2021 and the close of 2020, the realities we face daily are still marked by the lingering effects of the very prominent Covid-19 Pandemic. However, this year is filled with hope – hope for the successful dissemination and impact of the Covid-19 vaccination, which has begun circulation and administration across the United States; hope for increasingly more efficient testing and results; and hope for a return to some sense of



normality, which brings us slightly closer to the lives we all remember from a year ago.



As members of the legal profession, what Covid-19 represents to us on a daily basis is backlogged courts with less available hearing time, virtual hearings/trials, and temperature checks at the Courthouse doors. For smaller firms, this brings with it a new host of obstacles, such as having to pivot and become far more technologically savvy, review hiring needs, and implementing practices and plans in the event the firm must work remotely.

According to a July 27th Law 360 article titled "Firms Must Note Pandemic's Outsize Impact On Women," the profession is at a "watershed moment where the massive upheaval caused by the pandemic has created a unique opportunity to implement meaningful structural and cultural changes that could benefit women in the legal field and the firms where they work" and that "[t]he key challenge for every law firm is to make sure that



diversity and inclusion are core values, with meaningful strategies, goals and achievements in our new normal."



Further, in an August 7th Law.com podcast titled "For Big Law's Working Moms, Pandemic Could Have a Silver Lining ... Seriously!" the argument is made that the pandemic has been a "unique moment in time," proving that working remotely, which reduces the need to travel, has shown progression in participation by women in the current job market. Now more than ever, women are juggling family life, remote schooling, and still maintaining a career. While we still struggle with the obstacles posed by the global

pandemic, we cannot forget what we have and continue to learn from it, as well as acknowledging the beautiful silver-lining of diversity and inclusion and, in particular, the increasing opportunities for women in the legal field.

#### **THE DOCTRINE OF UBERRIMAE FIDEI**

The doctrine of uberrimae fidei is a maritime doctrine that applies only when a marine insurer issues a policy. "Uberrimae fidei" means utmost good faith and the doctrine requires the insured to disclose to the insurer all known circumstances that materially affect the insurer's risk.

An applicant for a marine insurance policy has a duty to disclose all facts material to the calculation of the insurance risk, whether or not the insurer requested them. An "insured" might lose coverage if the insurer discovers not all relevant facts were disclosed on the insurance application. The matter here was whether or not the insured's policy was renewed or considered a new policy subject to uberrimae fidei when it was issued.

Alfredo Quintero owned a 32' Renegade powerboat insured under a Geico marine insurance policy. Two months prior to renewal, Geico sent a renewal package to Quintero advising the date and time certain when the policy would lapse and also that the premium had increased by twenty-five percent. Quintero told Geico the increase was unacceptable and they would lose him as a customer. Shortly thereafter Quintero received a "Notice of Policy Expiration".

Twenty days later, at 4:58 a.m., a pickup truck pulled up to Quintero's home and towed away the uninsured boat and trailer. The neighbor's surveillance camera recorded the incident. At 7:28 a.m. Quintero called Geico to reinstate his policy. The Geico representative asked Quintero if the boat had any damage and if it was seaworthy, but failed to ask him if it had been stolen that morning. The policy was reinstated effective immediately.

At 2:43 p.m., Quintero reported his boat stolen to the local police department who

was also provided with the surveillance footage. He then called Geico at 6:28 p.m. to report the vessel had been stolen. Quintero told Geico he discovered the boat missing when his wife came home from work. Geico investigated taking statements from Quintero and his wife. However.



Quintero refused to submit to an examination under oath.

Geico later informed Quintero that it had denied his claim and rescinded the policy ab initio because Quintero was not in possession of the boat when he called to reinstate the policy. Quintero filed suit arguing the policy had been renewed and backdated and was thereforeWW in full force and effect since the expiration date and uberrimae fidei could not apply. Ultimately the district court granted Geico's motion for summary judgment. The District Court concluded the policy was void ab initio under the uberrimae fidei doctrine "regardless of whether [it] was renewed, cancelled, or expired". Alfredo Quintaro v Geico Marine Insurance Company, 2020 U.S. App. LEXIS 40091, (11<sup>th</sup> Cir. Dec. 2020).

On Appeal, the Circuit Court ruled Quintero's misrepresentations concerning his possession of the boat during his call to Geico rendered his policy void ab initio. Quintero again argued uberrimae fidei did not apply because he was not issued a new policy. Nevertheless, the court found Quintero's original policy had expired, and whether or not he knew his boat was gone, it was not in his possession at the time the policy was renewed. The Circuit Court affirmed the ruling of the District Court, leaving Quintero without coverage for his loss.

Thanks to all those who attended the Appellate Committee's January 28, 2021, Zoom CLE on appellate bonds and stays. Although virtual CLEs are not ideal, we are fortunate to be able to take advantage of the Zoom platform this year to be able to host practitioners and Judges from across the State.

In case you missed it, the Florida Supreme Court has enacted several important changes to various rules which took effect on January 1, 2021. See In re Amendments to the Florida Rules of Appellate Procedure 9.120 and 9.210, No. SC20-597, 2020 WL 7062711

(Fla. Dec. 3, 2020), and In re Amendments to the Florida Rules of Appellate Procedure 9.120 and 9.210, No. SC19-884, 2020 WL 7062674 (Fla. Dec. 3, 2020). Despite the similarity of the titles of the opinions, the opinions discussed changes to various rules, so be sure to review both opinions and carefully note all of the revisions to the rules. Given the number



of rules changes, we advise you download the latest set of the Rules and review them *all* prior to commencing your next appeal.

Here are some highlights for you:

- New Rule 9.045 sets forth the formatting requirements for all documents filed in an appellate court, provides that the only fonts permitted are Arial or Bookman Old Style 14 point, and requires a new certificate of compliance.
- New word counts for computer-Wgenerated briefs are enacted in Rules 9.100, 9.125, 9.141, 9.210, • and 9.370.
- New Rule 9.120(d) deletes the requirement of service of a notice of cross-review, and deletes the exclusion of jurisdictional briefs in cases certifying questions of great public importance under Rule 9.030 (a)(2)(A)(v).
- New Rule 9.120(e) shortens the time for transmission of the record.
- New Rule 9.120(f), governing cross review, now requires a party who intends to raise issues on • cross review to identify the issues in the statement of the issues section of the jurisdictional brief. The identification of issues on cross review is also discussed in Rule 9.210(a), (c), and (f).
- New Rule 9.120(g) lengthens the time for service of the initial brief.
- Rule 9.210 (a) reflects that the only briefs permitted to be filed include the initial brief, answer brief, and a reply brief. A cross reply brief is only permitted where a cross appeal has been filed, or where the respondent identifies issues on cross review in its brief on jurisdiction to the Supreme Court.







#### **Democrat Proposals for Change in 2021**



In anticipation of a Biden Presidency, Democrat Senators Elizabeth Warren and Jerrold Nadler have proposed some pretty significant changes to the Bankruptcy Code in the form of the

"CONSUMER BANKRUPTCY REFORM ACT OF 2020"

Most Bankruptcy practitioners cite 10 rather dramatic issues in the proposed legislation:

- 1. No more Chapter 7 or 13. Instead these would be replaced by a "new" CHAPTER 10. The proposal would also eliminate the recently enacted Sub-chapter V under Chapter 11 for debtors and small businesses with debts under \$7.5 Million Dollars who would also file under the new Chapter 10. Businesses with more than \$7.5 Million Dollars in debt would continue to file under the existing Chapter 11.
- 2. The credit counseling required under the 2005 ACT would no longer be required.
- 3. 341 meetings (Creditor meetings would no longer be held in person and scheduled so as not to interfere with a debtor's work schedule.
- 4. A new standard of "Ability to Pay" would be implemented based on what is determined to be non-essential living standards such as payments on private schools for children; support for "adult children and family members such as elderly parents;" and items such as expensive vehicle payments. A minimum payment would be established based on nonexempt assets and income.
- 5. 3 Special categories of the new Chapter 10

would allow debtors to change the terms on their (1) mortgages; (2) other secured debt; and (3) general unsecured debt. (Sort of a "3 in 1" plan, or, "pick your own!")

6. Debtors with insufficient income or assets would receive immediate discharges without any payments.



- 7. Consumers in plans under the new chapter would receive discharges immediately upon confirmation of the plan as opposed to on the date of completion of payments.
- 8. All attorney fees would be allowed to be paid over time, unlike Chapter 7.

### 9. Both private and federal Student Loans would be dischargeable.

10. Rules would include strengthening the FAIR DEBT COLLECTION PRACTICES ACT and the CONSUMER FINANCE PROTECTION BUREAU in order to allow the inclusion of an "Unclean Hands" provision to disallow claims of creditors in violation when creating their debt obligations.

It will be interesting to see how much of this makes it to the finish line and how long it will take to get there, AND whether or not the proposed legislation will help or hurt debtors and creditors. I'm betting it will look a lot different before it gets there.

#### Florida Real Property and Business Litigation Report

Lucoff v. Navient Solutions, LLC, Case No. 19-13482 (11th Cir. 2020).

A person who consents online to be contacted regarding past due debts even though he earlier advised the company he did not wish to be contacted has, as a legal matter, changed his preference and cannot claim a violation of the Telephone

Consumer Protection Act of 1991 ("TCPA"), 47 U.S.C. § 227.

**In Re: Amendments to Florida Rules of Appellate Procedure 9.120 And 9.21**0, Case No. SC20-597 (Fla. 2020).

Changes to the Florida Rules of Civil Procedure, including certification and required fonts.

#### **Galleon Bay Corporation v. Board of County Commissioners of Monroe County, Florid**a, Case No. 3D19-1783 (Fla. 3d DCA 2020).

Florida Statute sec. 73.111 (the money to satisfy a condemnation judgment award must be deposited in the court registry within 20 days of the judgment) does not apply to inverse condemnation awards.

### **Kachkar v. U.S. Bank National Association**, Case No. 3D19-1961 (Fla. 3d DCA 2020).

A signatory to a mortgage, even if not a party to the foreclosure case, is permitted to intervene in proceedings to set a foreclosure sale.

### **Wahnon v. Coral & Stones Unlimited Corp.**, Case No. 3D19-2387 (Fla. 3d DCA 2020).

A trial court faced with invocation of a witness's invocation of the Fifth Amendment privilege against self-incrimination which impacts a party's right to discovery and access to the courts may fashion an appropriate balancing remedy, including but not limited to, staying the case, preventing a witness from testifying or a party from presenting evidence, and recognizing an adverse inference.

**Torruella v. Nationstar Mortgage, LLC,** Case No. 5D19-3298 (Fla. 5th DCA 2020). A party that has not been served in a lawsuit is not a "prevailing party" entitled to attorney's fees when the suit is dismissed.



**M & M Realty Partners at Hagen Ranch, LLC v. Mazzoni**, Case No. 18-13536 (11th Cir. 2020). A "binding financial commitment" from a third party, including a wholly owned business entity, is required in order to satisfy the financial requirement of the "ready, willing and able" standard for awarding specific performance.

**Persaud Properties FL Investments, LLC v. Town of Fort Myers Beach**, Case No. 2D19-1282 (Fla. 2d DCA 2020).

Abandonment of a non-conforming use requires voluntary discontinuation of the use combined with the intent the discontinuation be permanent, i.e., more than the passage of time is required for abandonment.

Schlechter v. Community Housing Trust of Sarasota County, Inc., Case No. 2D19-3619 (Fla. 2d DCA 2020).

Florida Rule of Civil Procedure 1.540 cannot be used to vacate the dismissal of an action based on a party's assertion it would not have agreed to the dismissal if it had the knowledge or information at the time of dismissal that it has now.

**JAK Capital, LLC v. Adam**s, Case No. 2D19-4371 (Fla. 2d DCA 2020).

A party claiming unenforceability of a mortgage Continued On Next Page ... Continued From Previous Page... due to fraud must plead fraud (not forgery) as a defense and must also prove the mortgagee seeking enforcement participated in the fraud.

### **Bank of America, N.A. v. De Morales**, Case No. 3D19-1782 (Fla. 3d DCA 2020).

Certiorari relief generally is not available to avoid the expense of continued litigation (including discovery) but is available where immunity from litigation altogether is asserted.

#### Bridge Financial, Inc. v. J. Fischer & Associates,

**Inc.** Case No. 4D19-348 (Fla. 4th DCA 2020). The owner of 5% of a corporate entity is a sufficient "owner" such that he cannot tortiously interfere with a contract with "his" company.

#### Digiport, Inc. v. Foram Development BFC, LLC,

Case No. 3D18-1651 (Fla. 3d DCA 2020).

The question of whether an idea constitutes a "trade secret" under the Florida Uniform Trade Secrets is typically a fact issue and thus summary judgment cannot be granted for a claim that design of a data center for a building constitutes a trade secret.

### **Koyfman v. 1572 Pledger LLC**, Case No. 3D19-1521 (Fla. 3d DCA 2020).

On rehearing, the Third District re-affirms that a person primarily liable on an obligation who pays the obligation is not entitled to subrogation against third parties, e.g., a party cannot pay off a second mortgage on which it is liable, have the mortgage assigned to it instead of having the mortgage satisfied, and then foreclose the "unsatisfied" second mortgage to extinguish junior liens.

#### **1440 Plaza, LLC v. New Gala Building, LLC,** Case No. 3D20-0120 (Fla. 3d DCA 2020).

A trial court stating that it was "granting" a party's motion but then asking for additional argument reflects the trial court was leaning toward a particular outcome but does not demonstrate the trial court had prejudged the case.

**Skylink Jets, Inc. v. Klukan**, Case No. 4D20-615 (Fla. 4th DCA 2020). The Fourth District recedes from prior precedent and holds that in some situations neither party in a contract action may be the prevailing party for purposes of an attorney's fees award.

**Baldwin v. Harris**, Case No. 5D19-2791 (Fla. 5th DCA 2020).

Directing that a payment be made in an estate planning document does not satisfy a contractual obligation that the payment be made.

**Wilcox v. Cupstid**, Case No. 5D20-359 (Fla. 5th DCA 2020).

An award of attorney's fees under Florida Statute section 704.04 (statutory right of way) requires a finding that one party unreasonably refused to comply with 704.01(2) and not just that one party prevailed.

**USF Federal Credit Union v. Gateway Radiology Consultants, P.A. (In re: Gateway Radiology Consultants, P.A.),** Case No. 20-13462 (11th Cir. 2020).

Debtors in bankruptcy are not entitled to receive Paycheck Protection Program payments due to the limitations set forth in the CARES Act, Coronavirus Aid, Relief, and Economic Security Act, Pub L. No. 116-136, 134 Stat. 281 (2020).

#### **Herrell v. Universal Property & Casualty Insurance Company,** Case No. 2D19-1911 (Fla. 2d DCA 2020).

Aligning itself with the Third District Court of Appeal, the Second District holds that for purposes of an award of attorney's fees a dismissal without prejudice is not the same as the dismissal with prejudice required by Florida Rule of Civil Procedure 1.442, Florida Statute section 768.79, and MX Investments, Inc. v. Crawford, 700 So. 2d 640 (Fla. 1997).2020).


