## Minimum wage increase

Did you know Florida's current minimum wage is now \$12.00 per hour? Also, if a business (such as a restaurant) takes a tip credit (such as for a bartender or server) the minimum wage for the tipped employee is now \$8.98 per hour for tipped employees, in addition to tips. ## Proposed increase to salary level for “exempt” employees

The proposed new salary level for white collar exemptions are being discussed by a lot of lawyers. I have seen nearly all of them declare that the proposed level will be \$1,059 per week or \$55,068 annually for a full-year worker. This is not entirely accurate.

The Department of Labor (DOL)'s Notice of proposed rulemaking is 267 pages long. Buried in a footnote (fn3) is language explaining that people still need to make comments and the DOL may change the number. However, if the number stays the same, that time delay means that the 35th percentile of weekly earnings of full-time salaried workers is projected to be higher in the fourth quarter of 2023. The DOL informed us that they project that the salary threshold could be \$1,140 per week or \$59,285 for a full-year worker.

I am not sure this will even take effect, but if you have exempt employees making less than \$60k and you are planning what to do if this change takes effect, please do not use the \$55,068 number. Please crunch your numbers using the \$59,285 number...and it may be even higher.

To make it even more complicated, if there is a little more delay and this become effective in 2024 instead of the end of 2023, then the DOL predicts that in the first quarter of 2024, the salary threshold could be \$1,158 per week or \$60,209 for a full-year worker.

So, if you have a salaried employee making below about \$60k, and if this proposed rule takes effect, you will need to increase the salary of your employees, or else begin tracking their hours so you can pay them overtime if they work more than 40 hours in a workweek.

## Real World Example:

Another story in the news about misguided DEI efforts. This company created an “Early Career” hiring initiative, which had the goal of changing hiring preferences to add more millennials to the workforce.

Boom. This just cost the employer a whopping \$2.4 million. Why? Well, this is age discrimination.

This is no different than if an employer wanted to add more women or blacks to the workplace and did so by discriminating against men or whites.

Discrimination is still discrimination, even if you think you have a good goal.

By the way, this wasn't a mom and pop company. This was a pharmaceutical corporation called Lilly USA, LLC, and its parent company, Eli Lilly and Company.

# Tennis Committee

## On the Court and In The Courtroom

Thanks for giving me the honor of heading up the MCBA Tennis Committee. I will start by telling you that my co-chair, Todd Thurlow and I have set a date for the Annual Tennis Tournament.

### MCBA Tennis Tournament

If you have never been to this event, you should know that it is, at minimum, fun to watch the finals. This year, if you play tennis, play in the tournament. However, if you don't play tennis but want to have lunch and watch the finals, please join us. This year we are going to showcase our finals.

I will finish by telling you a story that my partner, and immediate past Florida Bar President, Gary Lesser was able to witness at this year's U.S. Open in Flushing Meadows, New York.

It was the first round opening match for 19-year-old Coco Gauff against 35-year-old veteran player, Laura Siegemund. Siegemund is known for "slow play." However, in this match Siegemund continually blew the 25 second time clock, she was continuously not ready for Gauff's serve, which delayed Gauff from being able to move the match forward, she then took a 7 + minute bathroom break, violating the 3-minute bathroom break rule and the chair umpire was not penalizing Siegemund for her behavior. Gauff finally made a dramatic argument to the chair umpire pointing out the violations. If you watch tennis, this match was big news of the week. After all, it was the most drama we tennis fans have seen since Nick Kyrios left the scene.

Does this tactic by Siegemund sound familiar? While I watched this match, I thought "Wow, this is strikingly similar to a tactic out of some attorney's litigation playbook." That is, delay, file motion to create more delay, blow deadlines creating more delay, file another motion to delay more, make baseless objections creating more delay and forcing motions to be filed, then set a continuance hearing for months later, on an already delayed case.

If you have not experienced this tactic in litigation, you are lucky. Gauff did prevail in this match, and the chair did penalize Siegemund to correct her behavior. In the same way, our judiciary does assess penalties for abusive delay tactics. But, like Gauff, pointing out the abusive delay to the trial judge is often necessary. In Gauff's case she won the match. Similarly, those attorneys who intentionally delay typically lose the case and/or get sanctioned. Thus, justice was done on the court that day and is usually done in the courtroom where we encounter this tactic.

## A Cautionary Tale of Florida Relocation

Florida is now the fastest-growing state in America, according to 2022 population estimates by the U.S. Census Bureau<sup>1</sup>. While some are drawn to the sun, warmth, and beaches, others are drawn to Florida's tax benefits and homestead protections. Regardless of their decision to move to Florida, your new clients need to ensure they properly abandon their prior residency or risk having to pay taxes to their former home state. One Nebraska couple fell directly into this trap.

In *Acklie v. Nebraska Department of Revenue*, the Nebraska Supreme Court examined whether Duane and Phillis Acklie properly changed their residence from Nebraska to Florida. 982 N.W 2d 228 (Ne. 2022). In 1997, the Acklies purchased a residence in Florida and used it for rental income. In 2008, they: (1) moved personal property from Nebraska to their Florida residence; (2) obtained Florida driver's licenses; (3) registered vehicles in Florida; (3) registered to vote and voted in Florida elections; (4) obtained Florida homestead exemption for their Florida residence; (5) joined a Florida church and Florida country club; (6) maintained bank accounts in Florida and had statements mailed to their Florida residence. In 2012, the Acklies updated their passports that identified them as Florida residents.

While this is likely enough evidence to establish Florida residency, the Nebraska Department of Revenue found that the Acklies retained connections to Nebraska, including: (1) their daughters resided in Nebraska; (2) they had a vehicle registered in Nebraska; (3) Duane Acklie made various political contributions to Nebraska entities/candidates; (4) served as board members for Nebraska entities; and (5) in 2015, Duane was named "Nebraskan of the Year" by a Nebraska entity.

The Nebraska Court held that the "evidence to support the Acklies' assertion that they established a new domicile in Florida in 2008 was outweighed by substantial evidence of conduct during the audit period [2010-2014] that was inconsistent with an intention to abandon Nebraska as their domicile." *Id.* at 235. The Acklies had the burden of proof to show a change of domicile. *Id.* at 237. In this case, while there was conflicting evidence demonstrating two potential domiciles, Nebraska applies a presumption against a change in domicile in such situations. *Id.* at 239. Ultimately, the Acklies were liable for Nebraska income tax from 2010 to 2014.

For your clients who are new to Florida, let the Acklies' story serve as a cautionary tale. Although each state has its own rules for abandoning residency, and you do not need to commit them to memory, remember to counsel your clients to avoid remaining liable for unnecessary taxes.

# Real Estate and Commercial Litigation Update

## Florida Real Property and Business Litigation Report

**Thai Meditation Association of Alabama, Inc. v. City of Mobile**, Case No. 22-11674 (11th Cir. 2023).

Neighborhood character or zoning are not compelling government interests sufficient to justify abridging core constitutional rights, including exercise of religious beliefs.

**Noble Prestige Limited v. Galle**,

Case No. 22-11520 (11th Cir. 2023).

The Doctrine of Prior Exclusive Jurisdiction under *Princess Lida of Thurn & Taxis v. Thompson*, 305 U.S. 456 (1939), holds that a court of competent jurisdiction that first obtains possession, custody, or control of particular property cannot have its possession disturbed by another court.

**McGriff v. City of Miami Beach**, Case No. 22-12863 (11th Cir. 2023).

Government's own speech is not controlled by the First Amendment, and accordingly, it is free to choose what to say and what not to say including deciding what art to display or not display.

**In Re: Amendments To Florida Rule of Civil Procedure 1.530 and Florida Family Law Rule of Procedure 12.530**, Case No. SC2022-0756 (Fla. 2023).

The words "sufficiency of a trial court's findings in the final judgment" in subdivision (a) of both rules is replaced with "failure of the trial court to make required findings of fact in the final judgment" to make clear the rule applies only when a judge is required to make specific findings of fact and not when a party seeks to make other challenges to a trial court's order.

**Hess v. PMG-S2 Sunny Isles, LLC**, Case No. 3D21-1547 (Fla. 3d DCA 2023).

The assignor of a sales contract is entitled to an award of prevailing party fees and costs, even if it had no standing to enforce the contract, if the contract provides that assignor remained liable under the contract until the closing of the sales contract.

**Frehling v. Garcia**, No. 3D22-0949 (Fla. 3d DCA 2023).

The statutory enlargement of the application time period to port Save Our Homes exemption to a new property from two years to three years is not retroactive.

**M.P. v. Guiribitey Cosmetic & Beauty Institute, Inc.**, Case No. 3D22-1927 (Fla. 3d DCA 2023).

An "adhesionary" contract, including one for arbitration, is not necessarily unconscionable.

**Cape Coral Loan Acquisitions, LLC v. 924 Del Prado, LLC**, Case No. 6D23-401 (Fla. 6th DCA 2023).

A settlement agreement in which a settling borrower waives "any defenses of any nature whatsoever" includes a statute of limitations defense.

**CCP Harbour Island, LLC v. Manor at Harbour Island, LLC**, Case No. 2D22-2922 (Fla. 2d DCA 2023).

Employment of ruthless negotiation tactics, even for issues not part of the litigation, does not sufficiently affront "conscience, morality, or the law" so as to constitute the type of "wrongfulness" that qualifies for punitive damages.

**Asset Recovery, Inc. v. Wells Fargo Bank, N.A.**, Case No. 6D23-282 (Fla. 6th DCA 2023).

Foreclosure sale surplus arises ten days after the clerk issues the certificate of disbursements and no objection is received.

**Ramle International Corp. v. Miami-Dade County**, Case No. 3D20-0114 (Fla. 3d DCA 2023).

Florida Statute section 197.502(4) holds that a party seeking tax deed sale surplus funds must establish it was one of the persons listed under the statute to recover surplus funds, i.e., "the titleholder to the property up for sale, [a]ny lienholder of record who has recorded a lien against the property,' and [a]ny mortgagee of record."

**Miami Dade College v. Nader + Museu I, LLLP**, Case Nos. 3D20-663 and 3D20-1014 (Fla. 3d DCA 2023).

A trial court may offset competing judgments when the entry of separate judgments would create an absurd result.

**Green Tech Development, LLC v. Kahn & Resnik, PL**, Case No. 4D2022-2194 (Fla. 4th DCA 2023).

A debtor may overcome a prima facie case of an account stated by proving fraud, mistake, or error in the account but a party’s objection to only certain items on the bill implicitly admits the correctness of those items not challenged.

**Waterside at Boynton Homeowners’ Association, Inc. v. Southern Homes of Palm Beach, LLC**, Case No. 4D2022-2211 (Fla. 4th DCA 2023).

A settlement agreement may be set aside for mutual mistake of fact, but only if the mistake is mutual (the parties agreed to one thing and the written agreement expresses something different due to either a scrivener’s error or inadvertence) and the fact is of the essence of the contract.

**AFP 103 Corp. v. Common Wealth Trust Services, LLC**, No. 3D21-2117 (Fla. 3d DCA 2023).


Upon rehearing, the Third District withdraws its prior opinion that easements created by landowners are void ab initio and decides the case on the basis that AFP had no interest in the property as the dominant estate.

**Costco Wholesale Corporation v. Vargas**, Case No. 3D22-585 (Fla. 3d DCA 2023).


A corporate representative who deposition is being taken does not need to have personal knowledge of the listed deposition topics but is not permitted to use an undisclosed and unproduced set of answers nor to be coached by the attorney defending the deposition.

**Riggins v. Clifford R. Rhoades, P.A.**, Case No. 6D23-489 (Fla. 6th DCA 2023).

A court deciding a Motion to Dismiss may not stray outside the four corners of the complaint, including reviewing judgments from other courts, in order to decide the motion.

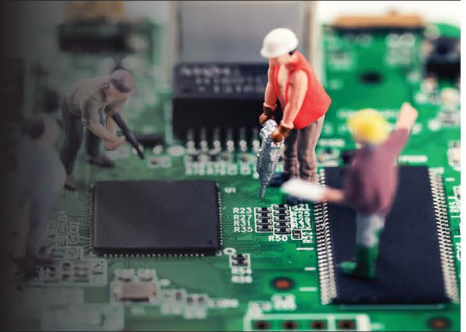

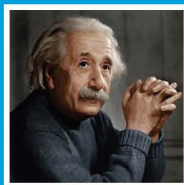
