

# Admiralty and Maritime Law

### SPECIAL MARITIME RULES OF COURT

The Supplemental Rules for Admiralty or Maritime Claims are located after the last of the rules in the book of Federal Rules of Civil Procedure. The scope of the Supplemental Rules, which govern procedure with respect to various maritime remedies, is identified in Rule A and the rules are detailed in Rules B through F:



Rule A: These supplemental rules apply to maritime attachment and garnishment, actions in rem, possessory, petitory, and partition actions, actions for exoneration from or limitation of liability, forfeiture actions in rem arising from a federal statute, and the procedure in statutory condemnation proceedings.

Rule B: Maritime Attachment and Garnishment. This rule is applicable when a maritime defendant is not found within the District of the court where a maritime complaint has been filed, It provides for attachment and garnishment of a defendant's property that is within the District.

Rule C: Special Provisions. This rule is applicable for in rem actions against maritime property to enforce a maritime lien and whenever a statute of the United States provides for a maritime action in rem or a proceeding analogous thereto.

Rule D: Possessory, Petitory, and Partition Actions. This rule is applicable in all actions for possession, partition, and to try title or possession with respect to a vessel, cargo, or other maritime property or between part owners.

Rule E: Actions in Rem and Quasi in Rem. This rule supplements rules B, C, and D, and provides the detail, execution and service of process, and security required in and for such complaints.

Rule F: Limitation of Liability. This rule provides the means, security required, and process for a vessel owner to seek exoneration from, or limitation of, liability to, claimants who allege tort claims against a vessel. It provides for timing, deposit of security, injunction, notice to claimants, and contents required in the vessel owner's complaint for exoneration from or limitation of liability.

Rule G: Forfeiture Actions In Rem. This rule governs a forfeiture action in rem arising from a federal statute. It states the content, process, and notice requirements for the complaint and for the responsive pleading.

### **Contracts After Death: Binding on Estate or Accidental Will?**

Personal representatives have the unenviable task of determining whether a contract is enforceable on the estate, if it expired along with the decedent, or if it is a contract to make a will.

"The appropriate test to determine if a contract was intended to survive the death of one of the contracting parties where the contract is otherwise silent on the issue, is whether the personal representative may perform as fully and as well as the decedent might have." *Bloom v. K & K Pipe and Supply Co., Inc.*, 390 So. 2d 770, 773 (Fla. 4th DCA 1980). Accordingly, a personal representative can properly refuse to perform a decedent's contract when it is "personal" to the decedent. Id. The contract is "personal" if it only contemplates the personal performance of the decedent, such as



a personal services contract. *Id.* In *Bloom*, the Court determined that a non-compete agreement was personal to the decedent and not enforceable. *Id.* The Third District Court of Appeals determined that a lease extension agreement that specified the decedent was personal and not enforceable by the personal representative. *Frankel v. Bernstein*, 334 So. 2d 37, 39 (Fla. 3d DCA 1976)

The personal representative has a duty to carry out the decedent's non-personal contracts and, if they fail to do so, they may be compelled to pay damages with the assets in their hands. *Frissel v. Nichols*, 114 So. 431, 434 (Fla. 1927). In *Gunderson v. School District of Hillsborough County*, the Court determined that a pre-death settlement agreement with the decedent's employer was enforceable by the personal representative. 937 So. 2d 777, 780 (Fla. 1st DCA 2006). Because the settlement agreement's performance could statutorily be performed by the personal representative, the contract was not personal to the decedent and thereby enforceable. *Id.* 

When a person intends a contract to survive death, they run the risk of accidentally making a contract to create a will under section 732.701, Florida Statutes. A written promise to leave money to an educational institution was deemed to be a contract to make a will and was not executed with the necessary formalities. See *Talmudical Academy of Baltimore v. Harris*, 238 So. 2d 161, 161-62 (Fla. 3d DCA 1970). An oral contract to care for the decedent in exchange for being named as the principal beneficiary of the estate was considered a contract to make a will and invalid for failing to be in writing and having two witnesses. *Renfro v. Dodge*, 520 So. 2d 690 (Fla. 4th DCA 1988).

When drafting contracts for your clients, practitioners should be aware of these general rules, especially when drafting contracts that may be later deemed invalid under section 732.701, Florida Statutes.

# Elder Law

### **Elder Law Attorney Corner**

What is an Elder Law Attorney Anyway?

No, it's not an attorney over the age of 65, as one 95-year-old woman asked one day when I told her I was an elder law attorney. So then, she asked, "What do you mean by you are an elder law attorney? What do you do?"

First, the practice of elder law requires a level of competency in many areas of law in order to practice with a level of proficiency as an attorney to serve the consumer.



The competencies an attorney should develop on his or her journey to move in the direction of developing an "elder law practice" includes, but is not limited to: estate planning with wills & trusts, trust administration, guardianship, probate, incapacity planning, end-of-life decision-making, Social Security law, Medicare benefits, Medicaid law, SSI law, special needs asset protection trust planning, understanding of the use of ABLE accounts for disabled adults, Veterans Benefits laws, nursing home resident rights law, nursing home neglect, exploitation laws, real estate law, income tax law, and estate tax law. These are all areas of law an attorney should develop a level of competency in to be able to, at a minimum, spot issues and discuss with clients or refer the person to an attorney with specialization in the area the client has an issue with.

Typically, the journey to becoming an elder law attorney takes years, and includes hours of continuing education, participation in elder law listservs to learn, membership in national organizations, and state Bar organizations and committees focused on imparting knowledge of topics and laws affecting the elderly and disabled. Back in 1995 I started my law practice focusing on probate, guardianship, simple estate planning, incapacity planning, nursing home neglect, and real estate law. For several years I studied various other areas of elder law to develop my competencies. Eventually I segued my way into a personal comfort zone where I felt comfortable holding myself out as an elder law attorney.

As Chair of the 2023 MCBA Elder Law Committee, my vision is to assist our committee members in developing all of our collective knowledge of elder law topics and impart our wisdom upon each other and the MCBA collective membership. The overarching goal is to increase the competency of attorneys services being offered to Martin County seniors and the disabled.



# Real Estate and Commercial Litigation Update

Florida Real Property and Business Litigation Report

Manuel Farach



City of Jacksonville v. Jacksonville Hospitality Holdings, L.P., Case No. 22-12419 (11th Cir. 2023). Federal Rule of Civil Procedure Rule 41(a)(1)(A)(ii)permits а plaintiff only to dismiss an action without court order by filing "a stipulation of dismissal signed by all parties who [at any time] have

appeared" in the action.

# In re: Fundamental Long Term Care, Inc., Case No. 21-10587 (11th Cir. 2023).

Analysis of a conflict under 11 U.S.C. § 327 is a case by case analysis, but should focus on whether there exists a present (not a past) conflict.

# In re Amendments To The Florida Rules of Appellate Procedure, Case No. SC2023-0033 (Fla. 2023).

The Florida Supreme Court adopts proposed changes to the Rules of Appellate Procedure, including amending Rule 9.130(e) to reintroduce the five-day buffer between the deadline for initial briefs in non-final appeals and the deadline for appellees to serve their notice of intent to crossappeal.

# In Re: Amendments To Florida Rule of General Practice and Judicial Administration 2.215, Case No. SC2023-1114 (Fla. 2023).

Rule 2.215 is amended to require that individual judge and divisional practices and procedures, local rules, and administrative orders be placed on each circuit's website; that the practice of limiting attorneys or parties to communicate with the court solely by written letter is abolished; and that that each circuit must have a continuing review process in place to ensure that the requirements of the rule are met.

**Suzmar, LLC v. First National Bank of South Miami**, Case No. 3D22-1839 (Fla. 3d DCA 2023). Florida law does not recognize a claim for negligent lending absent there being a fiduciary relationship in addition to the creditor-debtor relationship.

# Zakharova v. Innovative Technologies & Consulting Limited Corp., Case No. 3D23-1180 (Fla. 3d DCA 2023).

A motion to extend a notice of lis pendens need not be filed within one year of commencement to be able to grant relief.

**Michael v. Lobbytools, Inc.**, Case No. 1D22-1649 (Fla. 1st DCA 2023).

No indemnification is required under Florida Statute section 607.0580(1) when a corporate officer is sued for disclosing trade secrets and not "by reason of the fact" that she was a corporate officer.

**Certified Motors, LLC v. Aventine Hill, LLC**, Case No. 2D22-2306 (Fla. 2d DCA 2023).

An option to renew a lease that does not contain stated terms presumes the parties agreed to renew on the same terms set forth in the original agreement.

**AT&T Mobility, LLC v. Rigney**, Case No. 3D21-2261 (Fla. 3d DCA 2023).

Florida Statute section 57.105(1)(b)'s "good faith argument for new law exception" does not apply to a motion for sanctions under section 57.105(1) (a) that a claim or defense is not supported by the facts of the case.

### Bric McMann Industries Incorporated v. Regatta Beach Club Condominium Association,

**Inc.**, Case No. 2D22-2454 (Fla. 2d DCA 2023). Florida Statutes section 768.72 allows a plaintiff to make a claim for punitive damages for gross negligence or intentional misconduct.

### **The MacDougald Family Limited Partnership, LLP v. Rays Baseball Club, LLC**, Case No. 2D23-9 (Fla. 2d DCA 2023).

A broad arbitration provision, e.g., on which uses the word "concerning," is nonetheless limited in scope if the broad application is limited to one issue such as interpretation of an instrument. **Pirman v. South Pointe Of Tampa Homeowners Association, Inc.**, Case No. 2D23-58 (Fla. 2d DCA 2023).

A homeowner in a community association does not need to pay an assessed fine in order to have sufficient "damages" to sue over the allegedly improper fine.

Chiquita Fresh North America, L.L.C. v. Port Everglades Terminal, LLC, Case Nos. 4D2021-3433 & 4D2021-3556 (Fla. 4th DCA 2023).

A party seeking damages for unjust enrichment must prove it conferred a direct benefit on the defendant.

# **CPPB, LLC v. Taurus Apopka City Center, LLC**, Case No. 6D23-2649 (6th DCA 2023).

The Sixth District aligns itself with the First District and in conflict with the Second, Third, Fourth, and Fifth Districts and holds that generalized allegations of harm are insufficient to invoke a district court's certiorari jurisdiction.

### Flamingo South Acquisitions, LLC v. Flamingo/ South Beach I Condominium Association, Inc.,

Case No. 3D22-656 (Fla. 3d DCA 2023).

A declaratory action which deals with election of condominium board members must first be arbitrated.

#### Factor Brokers, Inc. v. J&C Enterprises, Inc., Case No. 3D22-1029 (Fla. 3d DCA 2023).

A non-signatory to a contract containing an arbitration provision can be bound to arbitrate by virtue of a valid assignment of the contract.

# Monroe County v. Jabour, Case No. 3D23-145 (Fla. 3d DCA 2023).

A Partial Summary Final Order of a code enforcement special magistrate which does not decide whether a violation occurred is not a final order capable of being appealed.

### Florida Atlantic University Board of Trustees v. Harbor Branch Oceanographic Institute Foundation, Inc., Case No. 4D2022-0313 (Fla. 4th DCA 2023).

The Florida Legislature may not pass laws which impair the contractual relationships between parties; total or substantial destruction of the rights of parties is not required. **Stuart Roofing, Inc. v. Thomas**, Case No. 4D2022-2580 (Fla. 4th DCA 2023).

A party alleging a violation of the Florida Deceptive and Unfair Trade Practices Act must prove actual, and not just consequential, damages.

#### **T.G. United, Inc. v. AADD Properties, LLC,** Case No. 5D22-1147 (Fla. 5th DCA 2023).

Florida Statute section 83.232(5) provides for an immediate default if a non-residential tenant fails to timely pay rent into the court registry, but the automatic default provision is not triggered if the court orders rent to be timely paid into an attorney's trust account and the tenant fails to do so.

# **Royal United Properties, Inc. v. Royal**, Case No. 6D23-584 (Fla. 6th DCA 2023).

Certiorari relief may be sought for a trial court setting aside a notice of election to purchase corporate shares under Florida Statute section 617.1430(1)(b).

**Cole v. Plantation Palms Homeowners Association, Inc.**, Case No. 2D22-3068 (Fla. 2d DCA 2023).

An expert report which does not conclusively establish the cause of foundation cracking in several homes may still be sufficient to defeat summary judgment.

**TBC Florida, LLC v. Infinity Biscayne Myrtle Member, LLC**, Case No. 3D22-1317 (Fla. 3d DCA 2023).

While release of a debtor typically releases the debtor's guarantor, a guarantor who guarantees a lease is not released from liability when the guaranty specifies "Tenant" and the assignee became the new "Tenant" under the assigned lease.

**Federal Insurance Company v. Perlmutter**, Case Nos. 4D2022-1558, 4D2022-1560, & 4D2022-1562 (Fla. 4th DCA 2023).

The Fourth District follows the Third District and holds that a trial court must consider an evidentiary showing by both sides at the hearing of a motion to amend to allege punitive damages.

#### **Mortgage Assets Management, LLC v. Unknown Spouse**, Case No. 5D23-188 (Fla. 5th DCA 2023). A party that complies with the certificate process of Florida Statute sections 90.803(6)(a) and (c) is not required to produce a live witness on the

certificated matters at trial.
